HOW TO ENTER

Participants will select a charity of choice and enter a legal name, daytime phone number and valid email address to submit a vote in "People Helping People Charity Poll and Voter Sweepstakes". Voters may vote once per email address per day during the contest period. Your vote for an organization will be your entry into the "Voter Sweepstakes". Fairmont Federal Credit Union will not sell or share information received on the electronic entry form received during the voting process with any third party vendors or use for marketing purposes.

WINNER SELECTION

The Sponsor will grant cash awards to the three organizations that receive the most votes in the "People Helping People Charity Poll". In the event of a tie for first place the first (1st) and second (2nd) place prize money will be split evenly. In the event of a tie for second place the second (2nd) and third (3rd) place prize money will be split evenly.
